A RESOLUTION OF THE CHUCKANUT COMMUNITY FOREST PARK DISTRICT  
ESTABLISHING A REGULAR PROPERTY TAX LEVY

**WHEREAS**, the Board of the Chuckanut Community Forest Park District (“District”) has met and considered its budget for the calendar year 2014; and

**WHEREAS**, the District was created upon certification of election results on Proposition 1, “Formation of Chuckanut Community Forest Park District”; and

**WHEREAS**, the District is authorized to impose a regular tax levy without voter approval in an amount up to seventy-five cents per one thousand dollars of assessed valuation; and

**WHEREAS**, the final assessed valuation of the District is not available from the Whatcom County Assessor at the time of adoption of this resolution; and

**WHEREAS**, the Whatcom County Assessor’s estimated assessed valuation of taxable real property in the District is \$1,510,071,867.00; and

**WHEREAS**, the Board of the District desires to levy a regular property tax levy for 2014 in the approximate amount of twenty eight cents per one thousand dollars of assessed property value;

**WHEREAS**, a property tax levy rate of twenty eight cents per thousand dollars of assessed value applied against the estimated assessed valuation of the District equals \$422,820.12 (estimated assessed value of \$1,510,071,867.00 x 0.28/1000); and

**WHEREAS**, a public hearing was held on November 14, 2013 to discuss the annual 2014 property tax levy and revenue estimates; and

**NOW THEREFORE**, THE BOARD OF COMMISSIONERS OF THE CHUCKANUT COMMUNITY FOREST PARK DISTRICT, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

**Section 1.** A regular property tax levy is hereby authorized for the levy to be collected in the 2014 tax year. No levy was authorized in the previous year. The dollar amount of the actual levy amount this year shall be \$422,820.12.

**Section 2.** That the Board President be authorized to sign on behalf of the District, the Levy Certification hereto attached as Exhibit “A” authorizing and directed the County Assessor to levy regular taxes as outlined above.

**Section 3.** BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

**Section 4.** If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Board hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared

invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid, or unconstitutional, then the original Resolution shall be in full force and effect.
