

RESOLUTION NO. 2

A RESOLUTION OF THE CHUCKANUT COMMUNITY FOREST PARK DISTRICT ESTABLISHING THE AMOUNT OF THE 2015 PROPERTY TAX LEVY

WHEREAS, the Board of Commissioners (“Board”) of the Chuckanut Community Forest Park District (“District”) have given proper notice of the public hearing held, November 13, 2014, to consider the District’s current expense budget for the 2015 calendar year and the possibility of an increase in property tax revenues, pursuant to RCW 84.55.120; and

WHEREAS, the Board desires to maintain a regular tax levy rate as close to twenty-eight cents per one thousand dollars of assessed valuation in the District as possible; and

WHEREAS, the Board, after hearing and after duly considering all relevant evidence and testimony presented, determined that the District require an increase in property tax revenue from the previous year, in addition to that resulting from the addition of new construction and due to improvements to property and increases in assessed value due to newly constructed wind turbines, solar, biomass and geothermal facilities, and any increase in the value of state-assessed property, in order to discharge the expected expenses and obligations of the District and in its best interest;

NOW THEREFORE, THE BOARD OF COMMISSIONERS OF THE CHUCKANUT COMMUNITY FOREST PARK DISTRICT, WHATCOM COUNTY, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1: An increase in the regular property tax levy, in addition to the increase resulting from the addition of new construction and improvements to property, newly constructed wind turbines, solar, biomass and geothermal facilities, and any increase in the value of state assessed property, is hereby authorized for the 2015 levy in the amount of \$427,048.32, which is \$4,228.20 more than last year and is a percentage increase of one percent (1%) from the previous year.

Section 2. That the Board President be authorized to sign on behalf of the District, the Levy Certification hereto attached as Exhibit “A” requesting the County Assessor to levy regular taxes as outlined above.

Section 3. BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

Section 4. If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Board hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid, or unconstitutional, then the original Resolution shall be in full force and effect.
